

ALU SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS.

This document constitutes the "Official Rules" of the ALU Sweepstakes (this "Sweepstakes").

1. GENERAL ELIGIBILITY:

This Sweepstakes is open to individuals who are over the age of 21 at the time of entry. This Sweepstakes is void where prohibited or restricted by applicable law.

Each of the following is not eligible to participate in this Sweepstakes: employees of Altura NFT Ltd, a British Virgin Island limited company ("Sponsor"), Vendor, and either's respective parent companies, subsidiaries, affiliates, suppliers, including any vendors providing services in connection with this Sweepstakes (collectively, the "Affiliates"), and any owners, employees, agents, directors, officers (including members of their immediate family—i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren—or those in the same household) of Sponsor, Vendor, or any Affiliates.

2. How to Enter

Email <u>sweepstakes@alturanft.com</u> and paste in the body of the email the information posted by the Sponsor on its Social Media Platform regarding the then-current Sweepstakes.

3. WINNER SELECTION/PRIZES:

Grand Prize: The number of entrants chosen (the "Potential Winners") will depend on the currently ongoing Sweepstakes, (which will be detailed on X). Potential Winners will be selected in a random drawing from all eligible entries received from the Start Date to the End Date for each Sweepstakes. The drawing will occur on the End Date at 10:30 a.m. ET. The Potential Winners who accept the prize and meet all the qualification criteria will receive the prize will be the "Winners." The prize will consist of ALU tokens and potentially additional items provided by third parties, which will be noted in the specific Sweepstakes announcements on X. The value of these prizes will be subject to the then-currently ongoing sweepstakes and will depend on ALU's market price on the date each Winner receives their prize.

The odds of winning will depend on the number of eligible entries received. Prizes are non-transferable, not returnable, and cannot be sold or redeemed for cash. No prize substitution is permitted, except by Sponsor in case of unavailability, in which case a prize of equal or greater value will be awarded. 4. PRIZE NOTIFICATION:

Potential Winners will be notified via direct message, email, and/or phone, utilizing information the entrant provided with the entrant's entry. 6. SPECIAL SWEEPSTAKES LIMITATIONS (Cont.):

If a technical error or the like occurs that results in more Potential Winners than available prizes for a particular prize level, then Sponsor may elect to hold a random drawing from all eligible claims received to award the number of prizes for the level of prize in dispute that have not yet been awarded.

No Waiver. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Dispute Resolution. Except where prohibited by applicable law, Sponsor has the exclusive power to interpret these Official Rules, and Sponsor's decisions regarding any and all matters arising out of or related to this Sweepstakes are final and binding. All other issues and questions that are not covered in the preceding sentence, including those concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant or Sponsor shall be resolved individually, without resorting to any form of class action, and shall be governed by, and construed in accordance with, the laws of Delaware, without giving effect to any choice of law or conflict of law rules (whether of Delaware or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Delaware. In addition, any dispute relating to this Sweepstakes (including these Official Rules) shall be brought in the appropriate state or federal court having jurisdiction over the subject matter located in Delaware. Entrants hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non conveniens or lack of personal jurisdiction that they may have. Any and all claims, judgment, and awards shall be limited to actual out-of-pocket costs incurred by entrant or Sponsor, as applicable.
